What We Do With Your Information

Your contact information is used to distribute information to you through print and email communications. Your information will never be sold to a third party, and will never be given to a third party for permanent use without your permission. At our discretion, we occasionally share our mailing list with partners for one-time use for resources or information we deem useful to our members or beneficial to the natural gas industry. Your privacy is a priority.

What Do We Gather?

Northwest Gas Association only collects the information you give us. NWGA gathers and stores any information you provide to us via our website, in person or any other way. This includes signing up for our email lists, registering for an event, being a sponsor or partner of an event.

Our registration and membership forms require users to give us information that may include name, email address, physical address, focus areas, and similar information. We may use non-identifying aggregate data for use in annual reports or member/sector snapshots.

Our website (www.nwga.org) logs all visitors using web browser cookies and uses Google Analytics for statistical tracking. This information is used for internal purposes only and is not shared.
